DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

1. WHAT IS THIS PACKAGE FOR?
Use this product to prevent unsightly defecation and urination by Dogs on lawns, and around hedges, trees, shrubs, and vines. Also prevents digging by cats in flower and vegetable gardens, lawns and under bushes.

2. HOW DO YOU USE IT?
AS A DOG REPELLENT: To prevent defecation and urination by dogs, remove old fecal material and sprinkle ferti-lome DOG & CAT REPELLENT evenly on the affected area at the rate of 1 lb. per 110 sq. ft. Do not place in piles. Re-treat at least once per week until defecation and urinating stops. Resume treatment if problem re-occurs.

AS A CAT REPELLENT: To prevent digging by cats, fill any existing holes and sprinkle ferti-lome DOG & CAT REPELLENT evenly on the affected area at the rate of 1 lb. per 55 sq. ft. Do not place in piles. Re-treat at least once per week until digging stops. Resume treatment if problem re-occurs.

NOTE: Do not apply directly on plants, flowers or foliage (lawns excepted). Keep about one foot away from plants and painted surfaces. Do not apply to Dichondra or unusual ground covers. If material becomes compacted, it is easily broken up with a stick or screwdriver and will lose no strength.

3. HERE ARE THE RESULTS YOU MAY EXPECT!

When used as directed, ferti-lome DOG & CAT REPELLENT can help provide you with lawn areas free of fecal material from Dogs and stops Cats from digging in treated flower and vegetable gardens.
