**DIRECTIONS FOR USE:** It is a violation of federal law to use this product in a manner inconsistent with its labeling.

**1. WHAT IS THIS PACKAGE FOR?**

This package of ferti-lome BROAD SPECTRUM PERMA-TRIM is for people who desire an easier way to control undesirable grasses and weeds in lawns, and to trim along the edge of sidewalks, patios, driveways, curbs, fences, buildings, vacant lots, alleyways, gravel driveways, flower bed borders and around trees and shrubs. ferti-lome BROAD SPECTRUM PERMA-TRIM is a non-selective, ready to use herbicide that kills weeds and grasses on contact. Its phytotoxic properties are quickly inactivated on contact with the soil.

**2. HOW DO YOU USE IT?**

ferti-lome BROAD SPECTRUM PERMA-TRIM is ready to use - no mixing required. Shake well before use. Remove protective cap from jug. Screw applicator head on jug, being certain applicator head is screwed firmly on jug. Invert jug. Thoroughly wet foliage and stems of undesired vegetation. The width of the spray may be adjusted by either raising or lowering the jug. Application may be made any time you want to control undesirable growth of grass or weeds, but best results are obtained during warm sunny weather.

Heavy lawn grass and difficult to control perennial weeds such as Bermudagrass and Dallis grass will require more than one application to give complete control of top growth. To avoid drift to desirable plant foliage, apply only when air is calm. Make sure that spray does not contact leaves, green bark, bud crowns or broken bark on trees and ornamentals. Do not track from treated areas to untreated areas.

TRIMMING & EDGING around lawns, fences, sidewalks, curbs, trees, shrubs and other similar areas can be done by walking slowly holding jug 2"-6" above grass or weeds to be killed.

SPOT TREATMENTS can be made by applying ferti-lome BROAD SPECTRUM PERMA-TRIM to crabgrass, dallis grass, clover, plantains and other similar weeds. When making spot treatments apply only to undesirable plants, do not saturate surrounding area.

LARGE AREAS such as vacant lots, gravel walks and other unconfined areas can be treated by holding jug at waist height and walking slowly making sure that all undesirable plants are thoroughly covered with spray. Hold jug away from body to avoid contact with skin or clothing. Apply 1 gallon to 200 sq.ft.

**3. HERE ARE THE RESULTS YOU MAY EXPECT!**

ferti-lome BROAD SPECTRUM PERMA-TRIM used according to directions will control undesirable grasses and weeds and make trimming and edging in the yard easier. Under warm sunny conditions wilting will occur in 1 to 3 days and complete browning in 5-7 days.

**STORAGE & DISPOSAL**

Do not store near feed, foodstuffs, fertilizers, seeds, or pesticides. Do not reuse empty container. Wrap container and put in trash collection.
