The amended labeling referred to above is acceptable provided you adhere to the following conditions:


1. Make the following changes to your labeling:
 - a. On the first page, immediately following the product name, add "for use on bermuda grass lawns"..
 - b. In the "How do you use it" section, clearly state the maximum application rates for MSMA and cacadylic acid in lbs per unit area (with oz of product per unit area in parentheses) per application and per year.
 - c. In the "Environmental Hazards" section, change "disposal of wastes" to "disposing of equipment washwaters or rinsate".
2. Submit one copy of final labeling of this labeling for this product.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

This labeling supercedes all previously accepted labeling for this product (except supplemental labeling). A stamped copy of the label is enclosed for your records.

1. WHAT IS THIS PACKAGE FOR?

ferti•lome® IMPROVED BERMUDA GRASS WEEDER is especially formulated to kill Dallis Grass, Crabgrass, Nutgrass, Dandelion, Johnson Grass, Morning Glory and other listed weeds in Bermuda Grass lawns.

2. HOW DO YOU USE IT?

Use in a tank type sprayer. Mix 2 ozs. with each gallon of water. Use 2 ozs. of product to cover 1,000 sq. ft. Spray to thoroughly saturate weeds. Two or three treatments are usually necessary at 7-14 day intervals. Bermuda grass may be temporarily discolored after treatment, but will come back quickly depending on moisture and plant food available to grass. For best results mow lawn grasses before application.

NOTE: Do not apply with hose-end applicators. Do not spray seeded lawns until second year. Do not use on St. Augustine, Carpet, Centipede, Bahia or Dichondra grass lawns. Avoid contact with desirable vegetation such as shrubs, flowers and other ornamentals. If contact occurs, wash off immediately with water.

3. HERE ARE THE RESULTS YOU MAY EXPECT!

This effective weed killer will control unsightly Dallis Grass, Crabgrass, Nutgrass, Dandelion, Johnson Grass, Morning Glory and other listed weed growth for a more beautiful and uniform appearance of Bermuda Grass lawns.

STORAGE AND DISPOSAL

STORAGE: Store in original container. Keep in an area inaccessible to children and pets.

DISPOSAL: If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
