1. WHAT IS THIS PACKAGE FOR?

Use this product to kill Crickets & Grasshoppers around Shrubs, Flowers and in lawns. Also kills Fleas, Ticks, Ants, Cutworms, Armyworms, Chinch Bugs, Sod Webworms(lawn moths), Earwigs, Sow bugs(Pillbugs), Hyperodes(Turfgrass) weevil and larvae of Southern Chafer, European Chafer and Japanese Beetles.

2. HOW DO YOU USE IT?

FOR CRICKETS & GRASSHOPPERS: Apply uniformly, 12 ozs. to cover 150 sq.ft. around shrubs, flowers and in lawns. Do not water in after treatment.

FOR FLEAS, TICKS, ANTS, CUTWORMS, ARMYWORMS, CHINCH BUGS, SOD WEBWORMS(Lawn Moths), EARWIGS, SOWBUGS(Pillbugs), HYPERODES(Turfgrass) WEEVIL, and Larvae of SOUTHERN CHAFER, EUROPEAN CHAFER and JAPANESE BEETLE. Apply uniformly 12 ozs. per 150 sq.ft. Water in thoroughly after application to kill insects in this paragraph. Treat when insects first appear.

3. HERE ARE THE RESULTS YOU MAY EXPECT!

When used as directed, ferti-lome CRICKET & GRASSHOPPER BAIT will kill Crickets, Grasshoppers and other listed pests and thus help provide for more beautiful lawns and flourishing flowers and shrubs.

DISPOSAL
