1. WHAT IS THIS PACKAGE FOR?

This product provides fast and easy method for killing major houseplant pests such as Whiteflies, Mealybugs, Aphids, Spider Mites and Scale Crawlers.

2. WHO DO YOU USE IT?

WHEN TO APPLY: Spray at the first sign of insects, before infestation is Heavy. Mist twice, 7 days apart. Repeat treatment if reinfestation occurs. Do not apply to wilted or water stressed plants or plants in direct sunlight. For hard to kill insects, make 2-3 applications at 7-10 days apart.

HOW TO APPLY: SHAKE WELL BEFORE USING. Hold bottle 6" - 8" from the plant. Apply a fine mist to completely cover all plant surfaces including underside of leaves. Do not saturate plant surfaces. Avoid spraying blossoms.

3. HERE ARE THE RESULTS YOU MAY EXPECT!

When used as directed, this product will kill major houseplant pests such as Whiteflies, Mealybugs, Aphids, Spider Mites and Scale crawlers to help provide for healthy and attractive houseplants.
