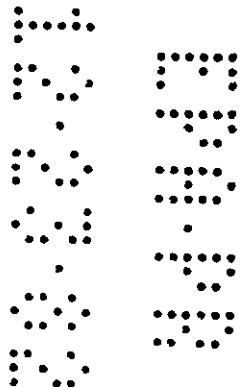

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

This product is a combination of two effective herbicides, 2,4-D & MCPP, that kills unsightly weeds and will not harm lawn grasses when used as directed.

TO APPLY: Use the rates listed in the table below. Spray entire lawn, wetting weeds and grasses. For best results, apply when weeds are actively growing. Use a hose-on or other type sprayer that will deliver enough water for a thorough coverage. For hard to kill weeds, repeat application in 2-3 weeks.

FOR BERMUDA, RED FESCUE, BENT, CENTIPEDE & CARPET GRASS LAWNS: Use one-half the rate listed in the table below (Ex: 3 teaspoonsful per gallon water). Temporary injury may occur. Make 2 applications 10 days apart. DO NOT APPLY TO DICHONDRA, LIPPIA, ST AUGUSTINE and CLOVER LAWNS.

Do not overspray. Do not water lawn for 48 hours after application. Spray when air is calm and avoid spray contact with desirable plants as they may be injured. Do not spray when temperatures are expected to exceed 85°F within 24 hours following application. NEWLY SEEDED LAWNS may be treated after they have been mowed at least 3 times.

*** Use one-half this rate for Bent, Bermuda, Red Fescue, Centipede and Carpet Grasses. NOTE: Do not use this product for weed control in flower or vegetable beds or around shrubs and other ornamentals. Do not reseed for 3-4 weeks after use.

STORAGE & DISPOSAL

Do not store near feed, foodstuffs, fertilizers, seeds, insecticides or fungicides. Do not store diluted spray. Do not reuse empty container. Wrap container and put in trash collection.
