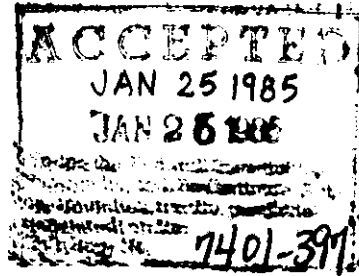

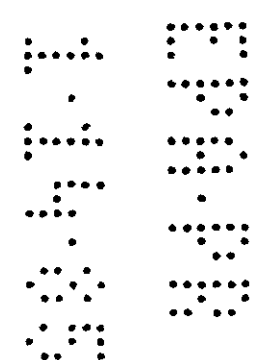
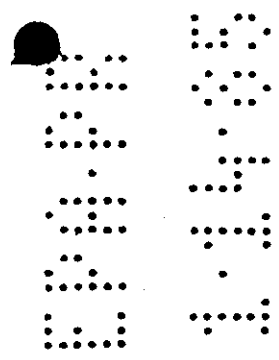

This time proven insecticide provides an effective means of preventing insects from chewing up Vegetables, Shrubs, Flowers and small Fruit & Shade Trees. Use this product to kill Thrips, Japanese Beetles, Armyworms, Squash Vine Borers, Leafhoppers, Cucumber Beetles, Mexican Bean Beetles, Bean Leaf Beetles, Blister Beetles, Cabbageworms, Cankerworms, Colorado Potato Beetles, Cowpea Curculio, Fleabeetles, Melonworms, Pea Weevils, Rose Chafer, Fose Slugs, San Jose Scale, Tent Caterpillars, Garden Webworms, Spittlebugs, Omnivorous Leaf Tier, Fleahoppers, Elm Bark Beetles, Gypsy Moths, Tussock Moths and Pine Bark Beetles.

VEGETABLES & FRUIT: Number in () following each crop heading indicates the number of days to observe between last application and harvest.

BEANS(3), BLACK-EYED PEAS(3) - Apply 4 ozs. to cover 100 sq.ft. Do not feed treated vines to livestock.

TOMATOES(7), SUMMER SQUASH(7), MELONS(7), CUCUMBERS(7), CABBAGE(7), SPINACH(14), BRUSSELS SPROUTS(14), TURNIPS(14), RADISHES(14) - Apply 4 ozs. to cover 100 sq.ft.

PEPPERS(7), EGGPLANTS(7), LETTUCE(14) - Apply 3 ozs. to cover 100 sq.ft.

STRAWBERRY(14), BLACKBERRY(14), RASPBERRY(14), BEWBERRY(14) - Apply 4 ozs. to cover 100 sq.ft.

APPLES(7), PEARS(7), PEACHES(21), PLUMS(7) - Dust on to obtain a full coverage application.

SHRUBS, FLOWERS & SMALL SHADE TREES - Dust on to obtain a full coverage application. Begin when insects first appear.

STORAGE: Store in original container and place in a locked storage area.

DISPOSAL: Do not reuse container. Wrap and put in trash.

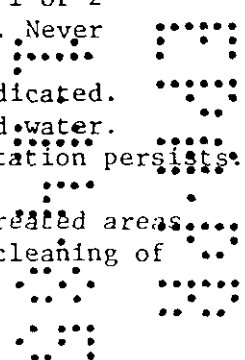
