It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product is a Non-selective Herbicide that will eliminate undesirable vegetation in lawns, driveways, parking areas, between stepping stones and bricks, around fences, patios, flower beds, buildings, trees, and shrubs without harm to untreated plants and vegetation. One application will kill most weeds and grasses. See list on both sides of front panel of this label for a partial list of weeds and grasses controlled.

How To Use In Rope and Wick Applicators - Fill applicator with concentrate. Make sure wick is thoroughly saturated but not dripping. Apply by rubbing the weeds or grass with the saturated wick.

How To Use As A Spray - To prepare a spray solution, mix 4 fl. ozs. with 1 gallon of clean water. Make a full coverage application being sure to thoroughly wet plant surfaces. Avoid cutting treated vegetation for at least 7 days. If certain hard to kill weeds and grasses are not completely killed in 14 to 21 days repeat application.

For spot treatment in lawns, flower beds, ornamental beds, around trees and shrubs, apply carefully to avoid contact with desirable vegetation. If spray or drift contacts desirable vegetation, wash off immediately with water.
