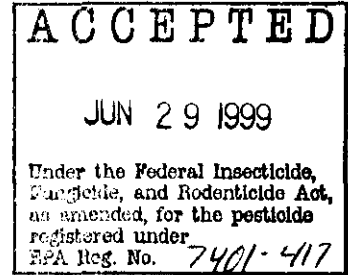

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Hi-Yield® Flea and Tick Killer kills fleas and ticks in and around your home. This product is ideal for treating pet sleeping areas, closets, door frames, baseboards, windows and localized areas of floor and floor coverings.

Application of this product in indoor residential settings, other than as a spot and/or crack and crevice treatment is not permitted.

INDOORS: Thoroughly apply, as a spray for spot treatment, to infested areas such as pet beds, resting quarters and along cracks and crevices where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Applications should be repeated as necessary. Do not treat pets with this product. To control fleas and ticks on pets, we recommend ferti-lome® Flea & Tick Killer.

OUTDOORS: Thoroughly spray doors, windows, frames, surfaces of screens and other areas where these pests may enter the home. Also treat around porches, in garages, around the yard, refuse dumps and other areas where these pests congregate. Application should be repeated as necessary.

STORAGE AND DISPOSAL

STORAGE: Store in original container and place in a locked storage area.

DISPOSAL: Do not reuse container. Wrap and put in trash.
