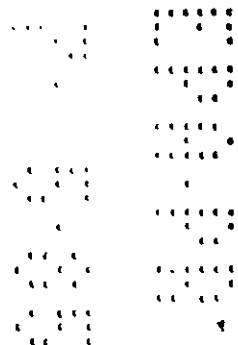

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

American Brand Dylox & MSR Garden Spray kills insects on Vegetables, Shrubs, Trees and Ornamentals. It provides two-way protection from insect attack. It kills insects on contact and is absorbed by the leaves and moves in the sap stream to all parts of the plant (Systemic Action). Working from inside the plant, it kills insects feeding on the foliage.

This product kills:

Aphids (including Elm aphid, Filbert aphid, Spotted pine aphid, Green peach aphid), Armyworms, Bagworms, Birch leaf miners, Climbing cutworms, Darkling ground beetle, Diamondback moth, Dipterous leaf miners, Elm leaf beetle, Holly leaf miners, Hornworms, Imported cabbageworm, Leafhoppers, Leafrollers, Lygus bugs, Mites (including Red Spider mites, Two-spotted spider mites, European Red mite), Scale (including European elm scale, Euonymus scale, Pine needle scale, Tea scale, Rose scale, Boxwood scale), Salt-marsh caterpillar, Stink bugs, Tarnished plant bug, Tent caterpillar, Thrips (including Gladiolus thrips, Cuban laurel thrips), Tobacco budworm, Webworms, Whiteflies.

TO APPLY - Mix 2 tablespoons in 1 gallon of water. Using any type of garden sprayer, apply to thoroughly wet upper and lower leaf surfaces and stems. Spray when insects first appear and repeat as necessary.

#### VEGETABLES:

Beans: Do not apply within 14 days of harvest.

Brussels Sprouts, Cabbage, Cauliflower: Do not apply with 21 days of harvest.

Corn: Begin spraying when plant is 3 - 12 inches tall and repeat as necessary to maintain control of insects. Full coverage sprays may be made up to day of harvest.

Lettuce: Applications may be made until heads begin to form. Do not apply within 28 days of harvest.

Peppers: Do not apply within 21 days of harvest.

#### ORNAMENTALS:

Flowers, Shrubs, Shade Trees: Begin spraying when insects first appear. Do not handle treated plants until spray has dried.

NOTE: Plant injury may occur on Royal Purple Smoke trees and on certain varieties of carnations and zinnias.

STORAGE: Store in original container and place in a locked storage area.

DISPOSAL: Do not reuse container. Wrap and discard in trash.

#### PRECAUTIONARY STATEMENTS

##### HAZARDS TO HUMANS & DOMESTIC ANIMALS
