DIRECTIONS FOR USE

(1) WHAT IS THIS PACKAGE FOR?

ferti-lome(R) Bagworm & Mite Spray provides two-way protection from insect attack. It kills insects on contact and is absorbed by the plant (systemic action) to kill sucking insects feeding on plant.

(2) HOW DO YOU USE IT?

To protect your Shrubs, Trees and Ornamentals from Bagworm and Mite damage, mix 2 table-spoons with 1 gallon of water. Using any hose-on or other garden sprayer, apply to thoroughly wet upper and lower leaf surfaces and stems. Spray when insects or their damage appear and repeat applications as necessary to maintain control.

NOTE: Plant injury may occur on Royal Purple Smoke trees and on certain varieties of carnations and zinnias.

(3) HERE ARE THE RESULTS YOU MAY EXPECT!

This product will protect your Shrubs, Trees and Ornamentals from Bagworm and Mite damage.

STORAGE: Store in original container and place in a locked storage area.

DISPOSAL: Do not reuse container. Wrap and discard in trash.
