TO DISINFECT AND DEODORIZE ENVIRONMENTAL SURFACES:

Heavily soiled surfaces must be cleaned prior to application of this product. Hold spray about 6-8 inches from surface. Spray until fine mist covers surface. Allow to dry for at least 10 minutes before disturbing surface.

TO ELIMINATE ODORS IN THE AIR: Spray upward into room for 2-3 seconds.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS
