Dear Mr. Dunn:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. A stamped copy of the labeling is enclosed for your records.

1. Please move the phrase "NON-FLAMMABLE" to a position as a substatement to the ingredient statement or to the back or side panel. The phrase must not be highlighted or emphasized such as using inordinately large type size, or sharply contrasting color (in your case, using large type in italics) so as to constitute a misleading safety claim.
2. Please move the child hazard warning statement "KEEP OUT OF REACH OF CHILDREN" to a position directly above the signal word "CAUTION". Delete the colon after the signal word.
3. On the side panel of your label, under the "Precautionary Statements" section, please move the signal word "CAUTION" to a position directly under the "HAZARDS TO HUMANS & DOMESTIC ANIMALS" statement. Please change the first sentence to read simply " Harmful if swallowed, inhaled or absorbed through the skin."

5. Please delete the phrase "or when necessary" from the statement "Repeat spraying in two weeks or when necessary".
6. The word "Back" in the phrase "SEE OTHER CAUTIONS ON Back PANEL" should be all upper case.

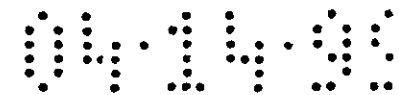

SHAKE WELL BEFORE USE

This product will kill ants, cockroaches, confused flour beetles, crickets, fleas, flies, mosquitoes, pill bugs, rice weevils, saw-toothed grain beetles, small flying moths and ticks. Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the areas during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table in center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary. Do not use this unit in a cabinet or under a counter or table. Do not use this unit in an area less than 100 cubic feet.

TO KILL FLEAS AND TICKS: Destroy pet's old bedding and replace. Use product as above. Treat dogs and cats with registered tick control product prior to re-entry.

#### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Avoid breathing vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with soap and warm water after use. Obtain medical attention if irritation persists. Avoid contamination of food or feedstuffs. Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Remove pets, birds and cover fish aquariums before spraying.

#### STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

IF IN EYES: Flush with plenty of water, get medical attention if irritation persists.

IF ON SKIN OR CLOTHING: Remove contaminated clothing and wash before reuse. Wash skin with soap and warm water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

PHYSICAL OR CHEMICAL HAZARDS: Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

#### STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Replace cap and discard container in trash. Do not incinerate or puncture.
