SHAKE WELL BEFORE USING

BEST RESULTS CAN BE OBTAINED IF NEST IS SPRAYED IN THE EVENING WHEN INSECTS HAVE RETURNED

Point nozzle away from face and in direction of the space to be treated. With wind at back, aim at nests in trees, bushes, under eaves, chimneys, cracks or crevices, etc. Spray while moving away from treated area. Thoroughly saturate nest with spray, contacting as many insects as possible. To prevent insects from falling on skin and clothes, do not stand directly under nest. If reinfestation occurs, repeat treatment.
