Kills Red Spider Mite, Citrus Rust Mite, Aphid, Scale and White Fly. Copper assists in the control of greasy spot and melanose.

## GENERAL INFORMATION

In order to produce good, bright fruit a spray program should be followed:

(1) Dormant Spray: January — spray using 3 1/3 Tbs. gallon. (4 pt. to 50 gallons.)

(2) Post Bloom Spray: Immediately after flower petals have fallen and before young fruits are 3/4" in diameter, usually in March or April, use 3 1/3 Tbs. per gallon.

(3) Pre-Summer Spray (May): 3 1/3 Tbs. to a gallon of water. (4 pts. to 50 gallons.)

(4) Summer Scalicide: If scales, white fly or sooty mold are present between June 15 and July 15, repeat No. 3

(5) Fall Spray: Usually October 15 to November 15. Use 3 1/3 Tbs per gallon. (4 pts. to 50 gallons of water)

TO PREPARE SPRAY: Mix with water at the rate shown.

Do not mix more spray than is to be used within a few hours.

APPLICATION: Spray plants thoroughly, applying to bottom and top surfaces of foliage and to the fruit. Do not use closer than 7 days of harvest. For more information on disease control — dilution rates — timing of applications, consult your State Agricultural Experiment Station or State Extension Service Specialist.

While best results may be expected by following the spray schedule, this material may be used any time during the year.
