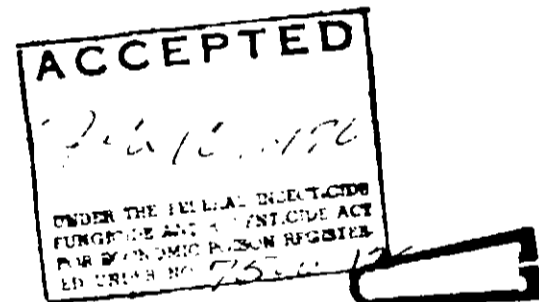

**DIRECTIONS:** To control most weeds and grasses on non-cropland areas such as railroad rights-of-way and industrial sites for an extended time, apply one (1) gallon per 1000 square feet of undiluted Black Jack Multi-Purpose Herbicide, after the most predominant weeds have emerged. No agitation is required. For treating small areas, a tank-type hand sprayer or sprinkling can may be used. For larger areas, truck mounted or other standard spray equipment should be used.

**NOTE:** Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to the use of Black Jack Multi-Purpose Herbicide in their areas. Avoid spray drift to susceptible plants as this product may injure cotton, beans, peas, grapes, flowers, fruit trees, ornamentals, or other desirable plants. (Coarse sprays are less likely to drift). Do not apply to areas underlaid by roots of desirable trees and shrubs. Vapors from this product may injure susceptible plants in the immediate vicinity. Thoroughly clean spray equipment with a suitable chemical cleaner before using for other purposes (or do not use same equipment for other purposes). Do not store near fertilizers, seeds, insecticides or fungicides. Do not re-use this container.

Black Jack Multi-Purpose Herbicide is toxic to fish and wildlife. Do not contaminate any body of water. Do not contaminate water by cleaning of equipment, or disposal of wastes.

Thoroughly clean equipment used for herbicide application (or do not use same equipment for other purposes). Do not store near fertilizers.
