General Information

Guadagnoli LORSBAN 50-SL insecticide is a wettable powder formulation designed for shurry treatment of seed prior to planting to protect the germinating seeds and seedlings against injury by seed-corn weevils. Guadagnoli LORSBAN 50-SL may be applied in combination with captan, chlorothal or thiram fungicides if protection of the seed from fungi, which may cause diseases or rot, is also desired. Seed treated with Guadagnoli LORSBAN 50-SL may be stored for up to 14 months without loss of insecticidal effectiveness.

Use and Dosage Recommendations

Field Beans, Green Beans, Kidney Beans, Lima Beans, Navy Beans, Snap Beans, Edible Soybeans, String Beans, Wax Beans, Field Corn, Sweet Corn, Cucumbers, Dill, Lettuce, Black-eyed Peas, Cabbage, Field Peas, Garden Peas, Okra, and Pumpkins (For control of seed-corn weevils and seed-corn beetles): Use 2 ounces of LORSBAN 50-SL per 100 pounds of seed by applying to the seed as a shurry treatment prior to planting.

Shurry Treatment

Dispense the required amount of Guadagnoli LORSBAN 50-SL in a water solution containing 0.5% by weight of METHOCEL™ AAC Phensin methy, stibone or other acceptable thickening agent. Use 12 to 15 fluid ounces of solution for each 100 pounds of seed to be treated. Generally, rough surfaced seeds such as corn will require a greater volume of solution for complete coating than smooth surfaced seeds such as beans. If a fungicide is
