The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. GUSTAFSON TOPS-2.5D is a fungicide formulated for the dry treatment of potato seedpieces to suppress *Fusarium* and *Rhizoctonia*. This pesticide will not control bacterial diseases or other diseases not claimed on this label for varieties known to be susceptible to bacterial soft rot. Companion fungicides known to be active against this organism should be used. Consult your extension potato pathologist for variety and treatment information.

For the suppression of potato seedpiece decay caused by *Fusarium* and *Rhizoctonia* spp., use 1 pound GUSTAFSON TOPS-2.5D per 100 pounds of cut seed pieces. Apply so that the cut seed pieces are thoroughly covered with dust by the use of a convenient container or dust attachment over the belt.

Thoroughly clean and sanitize cutting machines, knives, trays, tables, barrels, equipment, trucks and planters before cutting and planting seed pieces.

Do not use treated seed pieces for food, feed or fodder.

NOTE: This pesticide is to be sold ONLY in this original, unbroken package.
