GUSTAFSON TOPS-2.5D is a fungicide formulated for the dry treatment of potato seedpieces to suppress *Fusarium* and *Rhizoctonia*. This pesticide will not control bacterial diseases or other diseases not claimed on this label for varieties known to be susceptible to bacterial soft rot. Companion fungicides known to be active against this organism should be used. Consult your extension potato pathologist for variety and treatment information.

For the suppression of potato seedpiece decay caused by *Fusarium* and *Rhizoctonia spp.*, use 1 pound GUSTAFSON TOPS-2.5D per 100 pounds of cut seed pieces. Apply so that the cut seed pieces are thoroughly covered with dust by the use of a convenient container or dust attachment over the belt.

Thoroughly clean and sanitize cutting machines, knives, trays, tables, barrels, equipment, trucks and planters before cutting and planting seed pieces.

Do not use treated seed pieces for food, feed or fodder.
