The amendment referred to above, submitted in connection with registration under section (3) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided you make the following changes:

Storage and Disposal:

- Replace the subheading "Storage" with "Pesticide Storage".
- Replace the Pesticide Disposal statement text with the following: "Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance."

Consult with your local extension potato specialist for guidance and ways to control any possible resistant strains of fungi which may occur.

APPLICATION

For the suppression of potato seed-piece decay caused by *Fusarium* and *Rhizoctonia spp.*, use 1 pound GUSTAFSON TOPS-2.5D per 100 pounds of cut seed-pieces. Apply so that the cut seed-pieces are thoroughly covered with dust by the use of a convenient container or dust attachment over the belt.

Thoroughly clean and sanitize cutting machines, knives, trays, tables, barrels, equipment, trucks and planters before cutting and planting seed-pieces.

Do not use treated seed-pieces for food, feed or fodder. Apply only in areas with adequate ventilation or dust collection and control equipment installed. Do not substitute fans for ventilation in areas where application is made to cut potatoes.

NOTE: This pesticide is to be sold ONLY in this original, unbroken package.
