FIRST AID

1. **STORAGE:** Store in a cool place. Do not store in direct sunlight. Protect from freezing temperatures.

All other tank mixes should be pre-tested to determine physical compatibility between formulations. Observe all cautions and limitations on labeling of all products used in mixtures.

This product is to be used in liquid or slurry treaters.
