The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. The following specific comments pertain to your WPS labeling submission concerning the product cited above:

Add the following User Safety Recommendation to the label in the location shown in Section A on Part 1 of the Product Worksheet in Supplement Three-A to PR Notice 93-7: "Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing."

Delete the crossed-out statements on your proposed label. They are redundant statements or phrases.

Correct the typographical errors circled on your proposed label.

Applicators and other handlers (other than mixers and loaders) must wear: long-sleeved shirt and long pants, waterproof gloves, shoes plus socks, protective eyewear and dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C). Mixers and loaders must wear: long-sleeved shirt and long pants, waterproof gloves, shoes plus socks, chemical resistant apron when mixing or loading, protective eyewear and dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C).

STORAGE AND DISPOSAL

PROHIBITIONS

Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. Open dumping is prohibited. Do not reuse empty container.

STORAGE

Keep pesticide in original container. Do not put concentrate or dilute into food of drink containers. Store in a cool, dry place. Protect from excessive heat. Do not store or transport near feed or food.

PESTICIDE DISPOSAL

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 48 days.

Exception: For the last 48 hours of the REI, workers may enter the treated area to perform hand labor or other tasks involving contact with anything that has been treated, such as plants, soil or water, without time limit, if they wear the early-entry personal protective equipment listed below.

DIRECTIONS FOR USE

Gustafson Captan Lindarie 12.5-25 Seed Protectant is a dust based agricultural insecticide and fungicide especially formulated to help lubricate the planter box and assure smooth, even seed flow to the furrow. Gustafson Captan Lindane 12.5-25 Seed Protectant is formulated for use in the treatment of seeds for protection against wireworms, seed corn maggots and certain other soil-borne insects, as well as providing fungicidal protection at planting time. Where Seedlings Blight, Damping-Off or seed decay is severe, supplement this product with an EPA approved systemic protectant fungicide such as Vitavax® 200 Flowable Fungicide.

If soil temperature is extremely high (hot weather, midsummer planting or other reasons) reduce recommended dosage by one-half. Avoid lengthy storage of treated seed to prevent loss of Lindane.

Apply as a drill box treatment, mixing thoroughly with the seed before planting. For best results, the following procedure is suggested. Fill drill box only half full of seed, add half the required amount of Gustafson Captan Lindane 12.5-25 Seed Protectant and mix thoroughly with a stick. Then add remainder of seed to drill box and add the rest of the required amount of product to the seed, again mixing thoroughly.

Good results are also obtained by premixing seed with the product in a suitable container then pouring treated seed into drill box.

USE PRECAUTION

Wear goggles or face shield when handling. Wash thoroughly with soap and water after handling. Remove contaminated clothing and separately launder clothing before reuse.

A dust mask must be worn when mixing and loading this product. Mixers/loaders when mixing and loading this product must wear a long sleeved shirt and long pants or a coverall that covers all parts of the body except the head, hands and feet. Wear chemical resistant gloves, goggles or a face shield and a chemically resistant apron.

After work: Take off all clothes and shoes. Shower using soap and water. Do not wear contaminated clothing. Wash protective clothing and equipment with soap and water after each use. Personal clothing worn during use must be laundered separately from household articles. Clothing and protective equipment heavily contaminated or drenched with captan must be destroyed according to state and local regulations.
