

DIRECTIONS FOR USE

Gustafson Vitavax-PCNB Flowable Fungicide is a ready-touse seed treatment.

Gustafson Vitavax-PCNB Flowable Fungicide combines the systemic action of carboxin with the surface action of PCNB to control various seed and seedling diseases. It is particularly effective against *Rhizoctonia solani*.

BARLEY, WHEAT AND OATS

Use 3-4 fluid ounces of Gustafson Vitavax-PCNB Flowable Fungicide per 100 pounds of seed. Gustafson Vitavax-PCNB Flowable Fungicide should be applied as a slurry treatment by machine. Use the higher rate under conditions of expected heavy disease pressure.

In addition, loose smut (Uctilaco nude) and covered smut (Ustilago hordei) are controlled on barley, and loose smut (Ustilago tritici) and common burt (Tilletia caries) are controlled on wheat by Gustafson Vitavas-P(:NB Flowable Fungicide. heavy disease pressure. Do not graze or feed livestock on hay grown from treated seed.

SOYBEANS

Use 2 fluid ounces of Gustafson Vitavax-PCNB Flowable Fungicide per bushel of seed or 4 fluid ounces per 100 pounds of seed. Gustafson Vitavax-PCNB Flowable Fungicide should be applied as a slurry treatment by machine.

USE RESTRICTIONS

Do not use treated seed for food, feed or oil purposes. Do not graze or feed livestock on treated areas for six weeks after planting. Care must be exercised in the handling of treated seed. Since this product does not contain a dye, all seed treated with this product (except by the hopper box method) must be colored with an EPA-approved dye (e.g., 40 CFR 180.1001) which imparts an unnatural color to the seed to help prevent the inadvertent use of treated seed as food for man or feed for animals.

COMPATIBILITY

Gustafson Vitavax-PCNB Flowable Fungicide should not be tank mixed with any pesticide unless adequate physical and compatibility and phytotoxicity tests have been completed and proved to be satisfactory.
