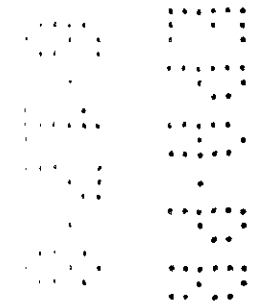

DANGER

GUSTAFSON CAPTAN-METHOXYCHLOR 75-5 SEED PROTECTANT is a special formulation containing Captan and Methoxychlor for seed treatment application. It is used in preventing seed rot and damp-off diseases on germinating seeds and seedlings and smut on onion and hulled sorghum seeds. It also reduces loss from Cadelle, Rice Weevil, Confused Flour Beetle, Angoumois Grain Moth during preplanting storage of clean seed.

SLURRY SEED TREATMENT: When used in slurry treaters, do not allow mixtures to stand overnight. Thoroughly mix the recommended amount of this product into the required amount of water for the slurry treater equipment and dilution rate to be used.

Note: Seed treated by the slurry method should not be bagged until such time as the seed has had an opportunity to dry. Store in a well ventilated areas. If seed is bagged when wet, heat is developed and seed germination will be impaired.

Gladiolus Corms: For Prevention of Bulb Rot - Use 1 1/2 oz. in 1 gal. water (1 lb. to 10 gals.) Soak bulbs in mixture 20 to 30 minutes.

Onion Seed Pelleting: Use 1 pound Gustafson captan Methoxychlor 75-5 Seed Protectant per 1 pound of seed.
