### STORAGE AND DISPOSAL

### DIRECTIONS FOR USE

**STORED GRAIN:** For protection of barley, oats, rice, sorghum and wheat against injury from stored grain weevils, moths, beetles and mealworms including granary weevil, rice weevil, red flour beetle, confused flour beetle, sawtoothed grain beetle, Indianmeal moth, and Angoumois grain moth. Apply to the grain at the rate of 10 lbs. of product per 1000 bu. as the grain is being loaded or turned into final storage. If grain is insect infested, fumigate\* to control existing populations and apply RELDAN for residual protection. To protect stored grains from attack by Indianmeal moth, apply to the surface of clean or infested grain at the rate of 7 lbs. per 1000 sq. ft. of grain surface area. Apply evenly. Repeat if necessary.

\*Fumigate with Phosphine or Methyl Bromide according to manufacturer's label recommendations.

### HOW TO APPLY TO SMALL GRAINS

Apply Gustafson RELDAN 3% Dust Insecticide when grain is in the truck or wagon prior to binning. To determine the amount in the truck or wagon, multiply the length by width by depth (all in feet) and multiply this total by 0.8 to get the number of bushels.

Measure out the correct amount of Gustafson RELDAN 3% Dust Insecticide (10 lbs. per 1000 bu.) and spread evenly over the surface of the grain in the truck or wagon. Cut into the grain with a shovel. Coating will become mixed with grain as it is dumped from the truck or wagon into the hopper. Further mixing will occur when the grain is augered or blown into the bin. Mixing is completed as the coating and grain roll down the cone shaped pile in the bin.
