RTU-VITAVAX-THIRAM Seed Protectant Fungicide is a readyto-use seed treatment. Apply as a commercial seed treatment or as a pour-on hopper-box application. This product does not require the addition of water for application.

RTU-VITAVAX-THIRAM Fungicide combines the systemic action of Carboxin with the surface action of thiram to control various seed and seedling diseases. It is particularly effective against *Rhizoctonia solani* and shows good activity against various *Helmintt osporium*, *Fusarium* and *Pythium* species. This often results in increased and more uniform stands of seedlings with higher yield potential. Use the higher rate under conditions of expected heavy disease pressure.
