FOR PLANTER BOX APPLICATION OR FOR USE ON SEED PRIOR TO PLACEMENT IN PLANTER BOX

Do not use any water. Apply CAPTN MOLY as a planter box treatment at the rate of 3.9 ou (3 level SCOOPS) per bushel of soybean seed. Plant soybeans at the rate of one (1) bushe acte for proper application of molybdenum. Treat half the seed in the planter box with ha required CAPTN MOLY and mix thoroughly with a stick or paddle until a uniform col imparted to all seed. Add the remaining seed and cover with balance of CAPTN MOLY thoroughly as above. Plant as soon as possible. Keep container tightly closed when not in u
