The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. If your product is currently suspended, the acceptance of this labeling amendment does not affect the suspension in any way.

AGRICULTURAL USE REQUIREMENTS
Use this product only in accordance with its labeling and with



the Worker Protection Standard, 40 CFH part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistances. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard. Do not enter or allow worker entry. Into treated areas during the restricted entry interval (REI) of 24 hours. RECOMMENDED APPLICATIONS

APRON-TERRACLOR will control damping-off, seed and seeding rot diseases caused by *Pythium spp.* and *Rhizoctonia solani*. APRON-TERRACLOR will also provide early season control of *Phytophthora* in soybeans.

PLANTER BOX TREATMENT

Apply at the specified rate and premix with the seed directly in the planter box at planting. A non-oil lubricant has also been added to help seeds flow more easily and evenly from the planter box. Use the higher rate of application in fields with a history of severe disease pressure.

SEED TREATER APPLICATION

APRON-TERRACLOR may be applied at planting time, utilizing the Gustafson CF-80* treater to maximize seed coverage. (*Calibrate the Gustafson CF-80 as per the manufacturer's instructions.) Do not use the CF-80 for applications to peanuts.
