APRON-TERRACLOR may be applied at planting time, utilizing the Gustafson CF-80\* treater to maximize seed coverage. (\*Calibrate the Gustafson CF-80 as per the manufacturer's instructions.) Do not use the CF-80 for applications to peanuts.
