

RECOMMENDED APPLICATIONS

KODIAK A T Fungicide will protect against seed and seedling rot diseases caused by Pythium spp. and Rhizoctonia solani.

PLANTER BOX TREATMENT

Apply at the specified rate and premix with the seed directly in the planter box at planting. A non-oil lubricant has also been added to help seeds flow more easily and evenly from the planter box. Use the higher rate of application in fields with a history of severe disease pressure.

SEED TREATER APPLICATION

KODIAK A'T may be applied at planting time, utilizing commercial seed treating equipment to maximize seed coverage. (*Calibrate the equipment as per the manufacturer's instructions.)
