For the suppression of potato seed-piece decay caused by *Fusarium* and *Rhizoctonia spp.*, use 1/2 pound TOPS 5 per 100 pounds of cut seed-pieces. Apply so that the cut seed-pieces are thoroughly covered with dust by the use of a convenient container or dust attachment over the belt. Thoroughly clean and sanitize cutting machines, knives, trays, tables, barrels, equipment, trucks and planters before cutting and planting seed-pieces.

Do not use treated seed-pieces for food, feed or fodder. Apply only in areas with adequate ventilation or dust collection and control equipment installed. Do not substitute fans for ventilation in areas where application is made to cut potatoes.
