If inhaled: Remove victim to fresh air. If not breathing give artificial respiration, preferably mouth-to-mouth. Get medical attention. If on skin: Wash with plenty of soap and water. Get medical attention if abnormal reaction occurs.

### ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and aquatic organisms. Do not contaminate water when disposing of equipment washwaters. In the event that treated seeds are spilled and cannot be salvaged, completely cover them with soil.

## DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Use only recommended rates. Lower amounts may not give the desired control. Excessive amounts may cause seed injury. This material is a special formulation of 4-Way which, when used at the correct application rates, protects peanut seed against seed or soilborne diseases such as damping-off, root rot, seed decay and seedling blight.

## STORAGE AND DISPOSAL

**PROHIBITIONS**—Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. Open dumping is prohibited. Do not reuse empty container.

**STORAGE**—Keep pesticide in original container. Do not put concentrate or dilute into food or drink containers. Store in a cool, dry place. Protect from excessive heat. Do not store or transport near feed or food.

**PESTICIDE DISPOSAL**—Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
