Amendment application of December 13, 1994

The Agency is conditionally approving an amendment to the registration of the above-reference product under the authority of section 3(c)(7)(a) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA). This amendment allows a 1-year time limited registration on cotton, to expire automatically on December 7, 1995. In addition, during the period that this amendment is effective, it will be subject to the conditions listed below. To maintain your registration you must:

- 1. Submit the three additional cotton field residue trials. There are insufficient geographical representation on cotton filed trials. These trials must include seed treatment data. These data must be submitted by March 30, 1995.
- 2. Make the following label change: Change the application rate on cotton to 4.75 fluid ounces per hundred
- 3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

You should note that if you fail to satisfy any of the conditions imposed on this registration, e.g., you fail to submit the required data by the specified deadlines or the data submitted were not generated in accordance with the application test guidelines, EPA my issue a Notice to cancel this amendment under section 6(e) of FIFRA.

You should also note that, regardless of whether you satisfy all application conditions, this conditional registration will expire automatically on December 7, 1995. Sales and distribution of the subject product bearing labeling for use on cotton after December 7, 1995 will be illegal. The tolerance authorizing residues of the subject product in cotton will expire automatically, on November 17, 1996. After that date, sales or distribution of food in interstate commerce containing any residue of the subject product will be in violation of the Federal Food, Drug and Cosmetic Act.

The Agency will not renew, extend or establish a new tolerance nor issue a conditional registration for cotton until the additional cotton field residue data have been submitted, reviewed and found acceptable.

A stamped copy of the labeling is enclosed for your records.
