### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For use by commercial seed treaters only. Mix thoroughly before use or use entire container at one time. All mixtures should be pre-tested to determine physical compatibility between formulations. Observe all cautions and limitations on labeling of all products used in mixtures.

### STORAGE AND DISPOSAL

**STORAGE:** Store in a cool place. Do not store in direct sunlight. Protect from freezing temperatures.

**PROHIBITIONS:** Do not contaminate water, food or feed by storage, disposal, or by cleaning of equipment. Do not reuse empty container. Open dumping is prohibited.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSAL:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

For treatment of squash seed destined for export to Israel.

**Squash:**

To provide early season protection of seedlings against injury by early season thrips, aphids and whiteflies, apply 1.5 fl. oz. per one kilogram of seed prior to planting as a slurry treatment so as to ensure thorough coverage.

For treatment of field corn seed destined for export to Argentina.

**Field Corn:**

For protection against *Delphacodes kuscheli* (thrip) as virus vector, *Diloboderus abderus*, *Cyclocephala signaticollis*, *Discynetus* sp., *Agrotis* sp., *Conoderus* sp., and *Astyris atomaculatus* apply 0.73 L to 1.09 L per 100 kg of seed prior to planting.

For treatment of field corn seed destined for export to Chile.

**Field Corn:**

For protection against Argentine weevil, thrips and *Phytoloma harmani* apply 1.04 to 1.56 L per 100 kg of seed prior to planting. Rates for *Phytoloma harmani* depend on seeding rate, use 0.23 L for 80,000 seeds and 0.36 L for 120,000 seeds.

For treatment of field corn seed destined for export to France.

**Field Corn:**

For protection against wireworm, seed corn maggot and early season suppression of flea beetle apply 0.73 L per 100 kg of seed prior to planting.

**NOTE:** The purchaser of this product is responsible for ensuring that all seed treated with this product are adequately dyed with a suitable color to prevent its accidental use as food for man or feed for animals. Refer to 21CFR, Part 2.25. Any dye added to treated seed must be cleared for use under 40 CFR, Part 180.1001.

### SEED LABELING:

Treated seed must be labeled "For Export Only-Not to be sold or offered for sale in the United States." Seed commercially treated with GAUCHO 480 must be labeled in accordance with all applicable requirements of the Federal Seed Act. Treated seed must not be used for or mixed with food or animal feed or processed for oil.
