Dear Mr. McFadden,

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Make the following changes to the label:
 - a. In the last sentence of the "If swallowed: "subsection of the "FIRST AID" section, change "Do not give anything to an..." to "Do not give anything by mouth to an...".
 - b. In the third sentence of the "STORAGE:" subsection of the "STORAGE AND DISPOSAL" section, change "...damaged drums should be place in overpack drums..." to "...damaged drums should be placed in overpack drums...".
- 2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration may be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

We would also prefer to have the boxed section on the first page of the label whose first line is "PRECAUTIONARY STATEMENTS" changed to the following standard format:

"KEEP OUT OF REACH OF CHILDREN"
"DANGER PELIGRO"

"Si usted no entiende...explain it to you in detail)."

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not discharge into lakes, streams, ponds, or public waters unless in accordance with a NPDES Permit. For guidance, contact the regional office of the Environmental Protection Agency.

STORAGE AND DISPOSAL

STORAGE: Do not stack more than five drums high. Drums should be opened in well-ventilated areas. Leaking or damaged drums should be place in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Not for use on agricultural establishments in hopper-box, planter-box, slurry-box or other seed treatment applications at or immediately before planting.

PRODUCTINFORMATION:

Busan 30A is specially formulated for the treatment of seed prior to storage and planting to protect seed from molds and other fungi causing storage loss and to protect seed from seedborne and soilborne fungi which cause seed decay, damping-off and seedling blights.



DIRECTIONS:

Thoroughly mix the recommended amount of Busan 30A into the required amount of water for the sturry treater equipment and dilution rate to be used. Clean equipment thoroughly between operations.

IMPORTANT:

Do not combine colloidal suspensions, wettable powder or emulsifiable concentrates unless previous experience assures compatibility.
