The active ingredient in this product, Azoxystrobin, can be persistent for several months or longer. Azoxystrobin has degradation products which have properties similar to chemicals which are known to leach through soil to ground water under certain conditions as a result of agricultural use. Use of this chemical in areas where soils are permeable, particularly where the water table is shallow may result in ground water contamination. This pesticide is toxic to freshwater and estuarine/marine fish and aquatic invertebrates. Drift and runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwater or rinsate.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. PROTÉGÉ-ALLEGIANCE WP Fungicide is a broad spectrum, preventative fungicide with systemic and curative properties recommended for the control of many important plant diseases. PROTÉGÉ-ALLEGIANCE WP may be applied as a seed treatment following the guidelines specified in the SEED TREATMENT TABLE section of this label.

GENERAL USE PRECAUTIONS

Crops in this label may be planted immediately after last planting. Do not plant other crops within 45 days after last planting.

APPLICATION:

Apply PROTEGE ALLEGIANCE WP Fungicide at the recommended rate using standard slurry or mist-type seed treatment equipment. Uniform application to seed is necessary to ensure seed safety and best disease protection. Seed should be sound and well cured prior to treatment. Product should be diluted with sufficient water to ensure complete seed coverage. Consult a seed treatment specialist regarding slurry rate recommended for soybeans treated with PROTEGE ALLEGIANCE WP Fungicide.

SEED LABELING: To meet U. S. Federal Seed Act requirements, all seed treated with PROTEGE ALLEGIANCE WP Fungicide should be labeled: TREATED SEED DO NOT USE FOR FOOD, FEED OR OIL PURPOSES.
