 - Insert the following after the product name: "Rival Pak is a Multipack that contains 5 gallons of Gustafson Rival Flowable Fungicide (Component A), two 1 pint containers (Component B) of Gustafason Alliance-FL Seed Treatment Fungicide and 1 pint of PRO-IZED Seed Colorant (Component C). THIS PRODUCT IS ONLY TO BE MIXED TOGETHER FOR USE ON SOYBEANS. Do not use any component separately. For Use Only in Closed System Commercial Seed Treatment Equipment." Insert the sentence in the First Aid section: "Call a poison control center or doctor immediately for treatment advice." as the first line in the "First Aid" section of the label for the ingestion

- d. Inside the box, each component should have the complete precautionary labeling for the individual product; however, the directions for use should be the directions approved for this registration. Those individual containers/packages should not list the individual EPA Reg. No.s but be labeled as EPA Reg No. 7501-193 (Component A, Component B or Component C). This is required because the packaging you describe would permit separating the individual components.
- e. The Environmental Hazards section should read:

"This pesticide is toxic to fish and aquatic organisms. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Cover or incorporate treated seed with soil. Do not clean equipment or dispose of equipment washwaters in a manner that will contaminate water resources.

This chemical is known to leach through soil into groundwater under certain conditions as a result of agricultural use. Use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in groundwater contamination."

DIRECTIONS FOR USE OF RIVAL PAK

Gustafson RIVAL Flowable Fungicide provides protection from seed and soilborne diseases which cause seed decay, damping-off (including Rhizoctonia spp.), seedling blights and pod and stem blight (Phomopsis spp.) during germination and early seedling stages. Gustafson ALLEGIANCE-FL Seed Treatment Fungicide provides control of Pythium seed rot and damping-off.

RIVAL PAK contains 5 gallons of Gustafson RIVAL FlowableFungicide, two 1pint containers of Gustafson ALLEGIANCE-FL Seed Treatment Fungicide and 1 quart of Gustafson Pro-Ized Seed Colorant. RIVAL PAK will treat 320 units (1unit is a 50 pound bag) of soybean seed. Prepare a slurry using: five gallons of Gustafson RIVAL Flowable Fungicide, 32 fluid ounces of Gustafson ALLEGIANCE-FL Seed Treatment Fungicide, 32 fluid ounces of Pro-Ized Seed Colorant and 2 gallons of water. Apply the 7.5 gallon slurry mix at a rate of 6 fluid ounces per hundredweight (equivalent to 3 fluid ounces of slurry per 50 pounds of soybean seed). Use commercial seed treating equipment. Refer to individual product labels for complete directions for use.
