This product is conditionally registered in accordance with FIFRA Section 3(c)(7)(A) provided that you:

- Make the following label changes before you release the product for shipment:

- Insert the sentence in the First Aid section: "Call a poison control center or doctor immediately for treatment advice." as the first line in the "First Aid" section of the label for the ingestion route of exposure.
- c. Place the "Storage and Disposal" section above the "Warranty Section" so that it will appear as a subpart under Directions for Use.
- d. Under Environmental Hazard, second sentence, delete "For Terrestrial uses only" and capitalize "d" in "do". This phrase is not needed as all uses are terrestrial.

- e. Revise the handler glove statement in Ag Use box so it is consistent with the glove statement in the PPE section.
- f. Delete the references to EPA Reg No.s 7501-114-42056 and 7501-112 on the the label.
- g. Move the spanish language statement: "Si usted no entienda la etiqueta . . ." to just after the initial Signal word (just under the phrase, Keep Out Of Reach Of Children). This should be immediately followed by the First Aid section and then the Precautionary Statements section.
- h. Inside the box, each component must have the ingredient statement for the specific product and the complete labeling for this registration. Those individual containers/packages should not list the individual EPA Reg. No.s but be labeled as EPA Reg No. 7501-194 (Component A, or Component B). This is required because the packaging you describe would permit separating the individual components.

Submit one copy of the revised final printed label before releasing the product for shipment. The Agency also request photographs of the product packaging that are sufficient to clearly demonstrate how the product is packaged. These photographs will be kept with the registration file.

If the conditions enumerated above are not complied with, the registration will be subject to cancellation in accordance with FIFRA Section 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

This pesticide is toxic to fish. For terrestrial uses,do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. It contains requirements for training, decontamination, notification, and emergency assistance. DIRECTIONS FOR USE OF STILETTO PAK

Vitavax T-L Seed Protectant Fungicide combines the systemic action of carboxin with the surface action of thiram to control various seed and seedling diseases. It is particularly effective against *Rhizoctonia solani* and shows good activity against various *Helminthosporium*, *Fusarium* and *Pythium* species. Gustafson Allegiance-FL Seed Treatment fungicide provides control of *Pythium* rot and damping-off.

Stiletto Pak contains two 2.5 gallon containers of Vitavax T-L Seed Protectant Fungicide and two 1 pint containers of Gustafson Allegiance-FL Seed Treatment fungicide. Stiletto Pak will treat 197 units (1 unit is a 50 pound bag) of soybean seed. To apply: Add 1 pint of Gustafson Allegiance-FL Seed Treatment Fungicide to each 2.5 gallon jug of Vitavax T-L Seed Protectant Fungicide. Shake well to mix the components together. Apply to soybean seed at a rate of 6.8 fl. ounces per hundredweight of seed (equivalent to 3.4 fluid ounces per 50 pounds of seed). Apply as a hopperbox application or through on-farm seed treatment equipment. Apply the proper amount of Stilleto Pak evenly over the surface of the seed. Mix until a uniform color is imparted to all seed.
