Broccoli, broccoli (Chinese), broccoli (raab), Brussels sprouts, cabbage (including Chinese bok choy, Chinese napa, and Chinese mustard), cauliflower, cavalo broccolo, collards, kale, kohlrabi, mizuna, mustard greens, mustard spinach, and rape greens.

For protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight, apply 0.051 - 0.34 fl. oz. of VORTEX per 100 pounds of seed.

CUCURBIT VEGETABLES

Chayote, Chinese waxgourd, citron melon, cucumber, gherkin, gourd edible (includes hyotan, cucuzza, hechima, Chinese okra), momordica, all muskmelon, pumpkin, squash and watermelon.

For protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight, apply 0.051 - 0.085 fl. oz. of VORTEX per 100 pounds of seed.

CEREAL GRAINS (Includes Forage And Silage)

Corn (field corn, popcorn, and sweet corn) and sorghum.

Corn (Field Corn and Popcorn): For protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight, apply 0.044 fl. oz. of VORTEX per 100 pounds of seed.

Sweet corn: For protection against seedborne and soilborne fungi which cause seed decay, damping-off, and seedling blight, apply 0.044 fl. oz. of VORTEX per 100 pounds of seed.

Sorghum: For protection against seedborne and soilborne fungi which cause seed decay, damping-off and seedling blight, apply 0.051 - 0.17 fl. oz. of VORTEX per 100 pounds of seed.

COTTON, SUNFLOWER

For protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight, apply 0.051 - 0.085 fl. oz. of VORTEX per 100 pounds of seed.

MUSTARD, RAPE, CANOLA

For protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight, as well as for protection against *Phoma lingam* causing blackleg, apply 0.051 - 0.34 fl. oz. of VORTEX per 100 pounds of seed.

ORNAMENTAL FLOWERS

For protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight, apply 0.051 - 0.34 fl. oz. of VORTEX per 100 pounds of seed.

CONIFERS

TURF GRASS

For protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight, apply 0.051 - 0.085 fl. oz. of VORTEX per 100 pounds of seed.

VORTEX is active against *rhizoctonia*, *fusarium*, and *phomopsis*. In addition, VORTEX provides activity against weakly pathogenic fungi such as *mucor*, *rhizopus*, *aspergillus*, *penicillium*, *alternaria*, and *cladosporium*. VORTEX does not provide activity against *pythium* spp or *phytophthora* spp. To provide best seedling protection against a wide array of fungal pathogens, apply VORTEX as a tank mix with ALLEGIANCE-FL. Consult the ALLEGIANCE-FL label to assure registration on crop, or if not labeled, use another labeled seed treatment product that has activity against *pythium* or *phytophthora*.
