c. In the first sentence in the second paragraph of the "PERSONAL PROTECTIVE EQUIPMENT (PPE)" section, add ", such as nitrile rubber, butyl rubber, or viton," immediately following "chemical-resistant gloves made of any waterproof material".

d. On the first page, just above the heading "FIRST AID", delete "PRECAUTIONARY STATEMENTS" and "HAZARDS TO HUMANS AND DOMESTIC ANIMALS".

e. In the "HAZARDS TO HUMANS AND DOMESTIC ANIMALS" section, delete "May cause allergic skin reactions." There is no evidence that the subject product is a sensitizer.

f. In the last sentence in the "ENVIRONMENTAL HAZARDS" section, change "sees" to "seeds".

3. Submit the following studies no later than one year following the date of this letter.

a. A pH study (Guideline Requirement Number 830.7000). If a waiver is requested, it must be in writing and with proper scientific justifications.

b. A one-year Storage Stability study (Guideline Requirement Number 830.6317).

4. Submit one copy of the revised final printed label for the record before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Three Way Peanut Seed Treatment fungicide is a special formulation developed for dry application to peanut seed. It is used for protection against seedborne and soilborne fungi causing seed rots and seedling blights, including *Rhizoctonia solani*, *Pythium* spp., *Rhizopus* spp., *Fusarium* spp., and *Aspergillus* spp.

**Peanuts:** Use 4 - 5 ounces per 100 pounds of seed. Apply with a standard commercial treating machine designed for dry formulations that provides uniform coverage to seed.

**USE RESTRICTION**

Do not use treated seed for food, feed, or oil processing.

**LABELLING OF TREATED SEED**

Seed commercially treated with Three Way Peanut Seed Treatment Fungicide must be labeled in accordance with all applicable requirements of the Federal Seed Act. All bags containing treated seed must be labeled or tagged as follows:

This seed has been treated with the pesticides, captan, trifloxystrobin and metalaxyl.

Do not use for feed, food or oil processing.

Store away from feeds and foodstuffs.

Seed that has been treated with this product must also contain the following labeling:

"This bag contains seed treated with captan. Persons opening this bag or loading/pouring the treated seed must wear long-sleeved shirt, long pants, shoes, socks, and chemical-resistant gloves."

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal, or by cleaning of equipment.

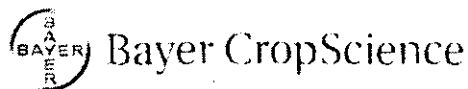
