

RATS: Apply 4 to 16 oz. of bait per placement. Maintain an uninternative rupted supply of fresh bait for at least 10 days. The amount of bait in this package is unlikely to be sufficient to kill more than one or two rats.

MICE: Apply 1/4 to 1/2 oz. (1-2 level tablespoons) of bait wite 8- 12 foot intervals. Larger placements (up to 2 oz.) may be nyeded at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

RATS/MICE: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources or rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treat-

ment. Where a continuous source of infestation is present estab- -- lish permanent bait stations and replenish as needed.

Storage: Store only in original container. in a dry place inaccessible to children and pets.


