The following amendment submitted in connection with registration under section 3(c)(7)(a) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable with the conditions listed below.

- Revise First Aid Section per PR Notice 2001-1
- Alternate Formulation for Basic Formula

Product Chemistry

- 1 The Confidential Statement of Formula of the alternate formula is in agreement with the basic formula, dated August 31, 1998, and accepted by the Agency on October 7, 1998.
- 2. The alternate source of the active ingredient is a registered EPA source.
- 3. The justification of the extended lower limits of the dye is acceptable given it does not change the chemical characteristics of the product.
- 4. The Confidential Statement of Formula (Alternate) dated February 20, 2002 is in compliance with the PR Notice 91-2 and in agreement with the label.

Conditions

Please revise the label as follows:

Page One

- 1. After the signal word, DANGER, delete the statement, "HARMFUL IF SWALLOWED. SEVERELY IRRITATING TO THE SKIN. CORROSIVE TO THE EYES."
- 2. Revise the Precaution referral statement to read "(SEE SIDE PANEL FOR

- 1. Revise the "Precautionary Statements" to read "DANGER. Corrosive. Causes irreversible eye damage and skin burns. Harmful if swallowed or inhaled. Avoid breathing vapors. Do not get in eyes, on skin, or on clothing. Wear protective eyewear, clothing, and rubber gloves. Wash thoroughly with soap and water after handling and before eating and drinking. Remove contaminated clothing and wash before reuse."
- 2. Delete "Phosphorous Content 0.00%."
- 3. Since this product is packaged in containers ranging from 1 gallon to 5 gallons, you must revise your "Storage and Disposal" statements as follows: (You should refer to PR Notice 83-3 and 84-1 for guidance).
 - A. For containers less than or equal to one gallon:
