1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. In the Environmental Hazards section, revise the statement "Do not discharge treatment effluent into lakes, streams, ponds, or public water unless in accordance with an NPDES permit" to read:

Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or public waters unless this product is specifically identified and addressed in an NPDES permit. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority.
 - b. Delete the word "milk."
 - c. Delete the words "General Classification."
 - d. Delete the statement "Only for Sale to, Use, and Storage by Servicepersons."



PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER

Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not discharge treated effluent into lakes, streams, ponds, or public water unless in accordance with an NPDES Permit. For guidance contact your Regional Office of the EPA. Do not allow water that contains this pesticide to come in contact with grass or plants. Do not use in drinking water or in swimming pools.

STORAGE INSTRUCTIONS

Product should be stored above 32°F. and below 130°F. Keep container tightly closed when not in use. Keep plastic containers away from flames and extreme heat. Changes in temperature create air pressure inside drums. Use proper caution in unscrewing plug. Unscrew plug slowly, allowing air to escape before completely removing. If material is spilled, wear protective clothing. Dike and contain spill with inert material (dry sand, Fuller's earth, etc.) and transfer liquid and solid to separate containers for recovery or disposal. Remove contaminated clothing and wash before reuse. Store product only in original container. Do not reuse drum for food or drink.

DISPOSAL INSTRUCTIONS

PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

PESTICIDE DISPOSAL INSTRUCTIONS: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinseate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your state pesticide or environmental control agency, or the hazardous waste representative at the nearest EPA Regional Office for guidance.

CONTAINER DISPOSAL INSTRUCTIONS: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove contaminated clothing before reuse.

If swallowed, drink promptly a large quantity of milk, egg white solution or if these are not available, drink large quantities of water or alcohol. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may occur. The use of gastric lavage. Measures against circulatory shock, depression and convulsion may be needed.
