DIRECTIONS FOR USE

It is a violation of Federal law to use this product without its labeling.

INITIAL DOSE: When system is noticeably fouled, apply FORMULA 603 per 1,000 gallons of water as an initial dosage until 1 ppm chlorine residual is achieved by a chlorine test kit.

The use of this product does not require a maintenance dose treatment. The following procedure provides for a 4 hour chlorine-release "shock" which should be repeated as necessary to maintain the control.

SUBSEQUENT DOSE: When microbial chlorine demand is 1 lb. per 1,000 gallons of contained water, apply 1 ppm of chlorine residual in the recirculating water frequently enough to ensure proper disinfection should be applied to the water system at a minimum. Badly fouled systems must be cleaned before treatment.

DANGER

Corrosive to eyes and skin. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. Do not handle with bare hands.
