

DIRECTIONS FOR USE:

INITIAL DOSE: When system is noticeably fouled, apply 2.0 to 4.0 pounds of Formula 618 per 1000 gallons of water in the system. Repeat initial dosage until 1 ppm chlorine residual is established, as determined by a chlorine risidual.

SUBSEQUENT DOSE: When microbial control is evident, apply 1.3 > 2.0 pounds per 1000 gallons of contained water. Repeat as needed to maintain 1 ppm of chlorine residual in the recirculating water for at least 4 hours. Test water frequently enough to insure proper chlorine residual. This product should be applied to the water basin at a point where good mixing occurs. Badly fouled systems must be cleaned before treatment is begun.


