## **RODGERS Insecticide & Repellent**

INDOOR USE against flies, gnats, flying meths and mosquitoes: Direct spray upward toward all parts of the room, filling the room full of mist. Leave room closed for at least 10 minutes. Stay outside treated oreas until well aired.

For roaches, ants, silverfish, and waterbugs: Spray into cracks to drive them out. Then spray directly on insects and repeat as necessary. Spray generously around doors and windows where flies, roaches or ants rest, hide, or run. For residual repellency of these insects, be sure a deposit of spray coats the surface.

OUTDOOR USE: Spray surfaces wherever flies, gnats, ants, and mosquitoes congregate. Repeat application as needed.

Insecticide and repellent gives repellency upainst roaches, flies, and ants. Continued treatment of surfaces creates a buildup and increases repellency toward these insects. Repeat appliation as often as necessary. Product can be used as directed in food processing plants, restaurants, warehouses, garbage container areas, and recreational areas.

**CAUTION:** Foods should be removed or covered during treatment. All food processing suffaces should be covered during treatment or thoroughly cleaned before using. When using the product as a space spray in these areas, apply only when plant is not in operation.

CAUTION: Contents under pressure. Store below 100° F. Do not puncture can. Do not throw into fire or incinerator. Do not use near open flame.
