GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Aquacide-10 is used to control algae and fungi in recirculating commercial and industrial water systems. To its use, systems must be cleaned to remove algae, slime, and other deposits. An initial slug addition of 1.53 fluid ounces of Aquacide-10

per 1000 gallons of water to provide a concentration of 48 to 120 parts per million of Aquacide-10, based on the volume of water in the system, is recommended. Repeat initial dosage

Subsequent slug additions of 1.53 to 4.2 fluid ounces of Aquacide-10 per 1000 gallons

of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made to collection trays of the airwash system.

Aquacide-10 is used to clean air-washing systems that maintain effective mist eliminators. To its use, systems should be cleaned to remove deposits. An initial slug dose of 24.7 to 41.2 fluid ounces of Aquacide-10 per 1000 gallons of water should be employed each 1
