GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Algae-X

Use in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleared prior to using.

For pools having just visible algae growth add an initial fluid ounces of Algae-X per 10,000 gallons of water. To remove settled algae debris by cleaning. For treatment of a pool add initially 41 to 75 fluid ounces of Algae-X per 10,000 gallons of water. Subsequent additions of Algae-X per 10,000 gallons of water every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4 fluid ounces of Algae-X per 1,000 gallons of water.

Subsequent additions of Algae-X should be made every 5 to 7 days after initial treatment.

Algae-X is compatible with chlorine products used to treat pools, spas, and decorative fountains at an alkaline pH. Algae-X can be used on decorative fountains treated with chlorine chemicals and chemicals normally required. However, do not mix Algae-X with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of the home and away from food.

DISPOSAL: Do not reuse empty container. Wrap container for disposal.
