DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Aquacide-30 is used in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using . For pools having just visible algae growth add an initial fluid ounces of Aquacide-30 per to move settled algae debris by cleaning. For treatment of pool add initially 12.8 to 23.5 fluid ounces of per 10,000 gallons of water. Subsequent additions of 4 of Aquacide-30 per 10,000 gallons of water 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 2 to 4 fluid ounces of per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 1 of Aquacide-30 per 1,000 gallons of water. Additions of 0.5 to 0.8 fluid ounces of Aquacide-30 should be made every 5 to 7 days after initial treatment for maintenance. Aquacide-30 is compatible with used to treat pools, spas, and decorative fountains and maintain an alkaline pH. Aquacide-30 can be used on decorative fountains treated with chlorine chemicals and maintenance chemicals normally required. However, do not mix Aquacide-30 with concentrated dry or liquid chlorine products.
