WES-QUAT 1:256 is a one-step disinfectant cleaner that is effective against a broad spectrum of bacteria, is virucidal, fungicidal, and will prevent the growth of mold and mildew and their odors when used as directed.

WES-QUAT 1:256 R-82 is an effective one-step sanitizer-cleaner for use on non-lead contact surfaces.

When used as directed, WES-QUAT 1:256 will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas, and other places where bacterial growth can cause mal odors.

Statement of Practical Treatment

GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

WES-QUAT 1:256 is a proven "one-step" disinfectant - cleaner - sanitizer - fungicide - mildewstat - virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply WES-QUAT 1:256 to walls, floors and other hard (non-porous) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, mop or mechanical spray device as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Disinfection - To disinfect hard, non-porous surfaces, add 0.5 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes. The activity of WES-QUAT 1:256 has been evaluated in the presence of 5% serum and 400 ppm hard water by the AOAC use dilution test and found to be effective against a broad spectrum of gram negative and gram positive organisms as represented by:

Fungicidal Performance -

WES-QUAT 1:256 is an effective fungicide against *Trichophyton mentagrophytes* (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc., at 0.5 oz/gallon.

Mold and Mildew Control. At 0.5 oz/gallon, WES-QUAT 1:256 will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.

Virucidal Performance. At 0.5 oz per gallon use-level, WES-QUAT 1:256 was evaluated in the presence of 5% serum and 400 ppm hard water and found to be effective against the following viruses: Influenza A/Brazil, Herpes Simplex and Vaccinia on man-made environmental surfaces.

Sanitizing Non-Food Contact Surfaces (such as seats, walls, tables, etc.) At 0.5 oz per 5 gallon use-level, WES-QUAT 1:256 is an effective sanitizer against *Staphylococcus aureus* and *Klebsiella pneumoniae* on hard porous and non-porous environmental surfaces. 
